

Submittor posted false evidences in order to influence the jurors.

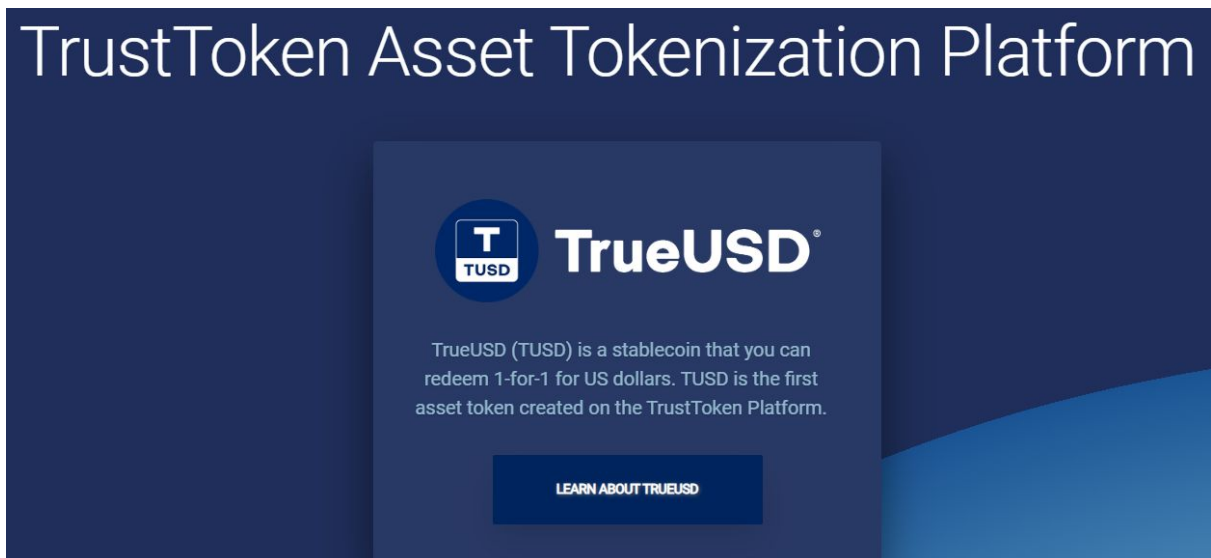
Proofs that the submitted logo is the wrong one :

1) TrustToken [official website](#) :

- TrustToken is the company issuing all True(currency) stablecoins tokens. USDT is the ticker of TrueUSD the token submitted to the court.
- Therefore, TrustToken own the IP and have the final word on the “Official Logo” of USDT

After some research, logo submitted (with US-flag background) was only used once in official TrustToken communication in a blog post promoting the release of several tokens pegged to several fiat currencies.

It's was a **temporary**, marketing design in order to help the user visually understand the difference among released token with the usage of country flag as background.

**It was never intended to be a permanent design and a no point the “us-flag” logo was a “official” and “long-term” design for TrustToken company.**

#### 4) Curated list jurisprudence.

In all previous arbitration cases of this court, jurors have favored the most up to date logo and the design considered official by the Token team (cases Huobi Token; case Wings as examples)

Therefore, jurors should reject the submission.
